## ARTICLES OF INCORPORATION

The undersigned, in order to form HAGERMAN I.D.E.A., INC., a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation, dated January 17, 2002, to the Secretary of State.

### ARTICLE I. NAME

The name of the Corporation is HAGERMAN I.D.E.A., INC. (I.D.E.A. standing for IMPROVEMENT, DEVELOPMENT, EDUCATION and APPRECIATION).

### ARTICLE II. PURPOSE

This corporation is formed for the PURPOSE of engaging in charitable activities within the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986 as that said Section may be subsequently amended.

Further purposes of this corporation are to: promote, foster and encourage Hagerman area improvement, development, education and appreciation; facilitate community-based planning and build community capacity; promote social welfare; encourage and promote development of industry and commerce; improve business conditions of one or more lines of business or commerce as distinguished from performance of particular services for individual persons, this later activity being specifically prohibited; and engage in any other activity for any lawful purpose for which non-profit corporations may be organized under the Idaho Business Corporation Act (Chapter III, Title 30, Idaho Code), provided, however, that all activity of the corporation shall be limited to the furtherance of exempt purposes within the intendment of Sections 501(c)(3) of the 1986 Internal Revenue Code as the same may be amended.

### ARTICLE III. REGISTERED AGENT

James F. Scott is the registered agent of the corporation. His street address is 160 Spring Street West, Hagerman, ID 83332.

### ARTICLE IV. DIRECTORS

The number of directors of this corporation shall not be fewer than five (5), nor more than eleven (11). The following persons shall act in the capacity of directors until the successors are elected and qualified:

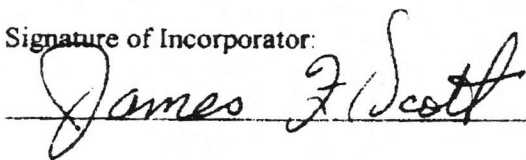
#### **ARTICLE VII. MEMBERS**

This Corporation shall have members and members shall be admitted to the Corporation in accordance with the By-laws of the Corporation.

#### **ARTICLE VIII. DISSOLUTION**

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by District Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
